## **SUMMARY:**

The Community Engagement Coordinator is responsible for broadening Tribal engagement in health topics such as tobacco control efforts. This position coordinates, develops, and executes outreach components of the project with a special emphasis on youth; assists Tribal Youth to develop and present information on health and tobacco issues to schools and organizations. Work with the community to increase the number of smoke free homes through education. Assists in writing reports, proposals, and progress reports.

#### **ESSENTIAL RESPONSIBILITIES & DUTIES**

- 1. Schedules meetings, including arranging logistics, agenda development, recording meeting minutes and effectively communicates with staff, Tribal Council and outside agencies.
- 2. Seeks regular consultation of CTCP Statewide Partners to increase training and coordination.
- 3. Assists with the formation and facilitation of the Youth Coalition.
- 4. Designs and develops trainings for youth coalition members.
- 5. Conducts strategic planning sessions with Youth Coalition members to identify short, intermediate, and long-term goals, organizational considerations, constituents, allies, opponents, targets, and tactics.
- 6. Coordinates, designs, and delivers training events and other project-related technical assistance.
- 7. Contributes to maintenance of project activities and ensures delivery of day-to-day deliverables.
- 8. Contributes to the writing of the project's progress reports, summary reports, reapplication proposals, technical reviews and/or new proposals that are relevant to the project.
- 9. Participates in team meetings, all staff meetings, and other applicable meetings, as requested.
- 10. Facilitates project meetings, as needed.
